FORMAT & SCORING

Member-Member

TEE TIMES:

Friday: 10am Tee Times Start

Saturday: 8am Tee Times Start

FLIGHTS:

- 48 teams.
- 8 flights with 6 teams each.
- Flight Pool Entry Fee \$200 per team cash (\$1200/Flight) Paid to the Golf Shop.

HANDICAPS:

- 85% handicap 10 stroke maximum between team members
- A player whose **age is 70 or above** may play from the white tees. Please note that once you have made the election, it cannot be changed during the competition.

FORMAT:

Better Ball Medal Play over Two Days (2 Rounds)

The winners of each division shall qualify for the championship playoff.

Flight Tie Breaker:

If there is a tie for 1st both teams in the flight will advance to the playoff.

Two additional teams will qualify for the Playoff as Wild Card Teams:

- First Wild Card Team: Non-division winner with the lowest 36-hole score Tiebreaker
 - 1. Last day score
 - 2. 2nd day score
 - 3. 1st day score
 - 4. Back side score day 3
- Second Wild Card Team: Team with lowest 18-hole score on day 2 (Sunday) that is not a division winner or a wild card team from #1 above Tiebreaker
 - Matching cards day 2 USGA rules
 - 1. Last 9 holes
 - 2. Last 6 holes
 - 3. Last 3 holes

Championship Playoff:

3-hole playoff of Better Ball Net on holes #7, #8 and #9 Tiebreaker is sudden death team aggregate net score on hole #9, then goes to overall score

<u>RULES</u>

Fall Member-Member

- All USGA rules apply unless modified by tournament local rules.
- All play is from Blue Tees except players age 70 or older who have made the White Tee election.

Local Rules:

Cell phone calls are prohibited at all times on the golf course during tournament play.

USGA Rules of Golf govern play, as modified by the following ACC Local Rules & Conditions:

Bunkers: Bunkers will be played as lift, clean and place. Ball must remain in the bunker at a spot that is no nearer to the hole.

Flower beds, Wood Chips, Mulch and ornamental planting areas: Treat as obstructions. Flower beds within paved areas are considered part of the obstruction. Relief is mandatory. No penalty.

<u>Aeration Holes</u>: *Through the green*, a ball that comes to rest in or on an aeration hole may be lifted without penalty, cleaned and dropped as near as possible to the spot where it lay but not nearer the *hole*. The ball when dropped must first strike a part of the *course through the green*. On the *putting green*, a ball that comes to rest in or on an aeration hole may be placed at the nearest spot not nearer the *hole* that avoids the situation.

<u>Aeration plugs</u>: Aeration plugs as well as other obstructions such as stump holes will be painted white and will be ground under repair. Relief is one club-length from the reference point, is not nearer to the hole than the reference point and must be in the general area. When taking relief, the player must take complete relief from all interference by the abnormal course condition.

Immovable Obstructions Close to the Putting Green: All fixed sprinkler heads are immovable obstructions and relief may be obtained under Rule 24-2. In addition, relief is provided from fixed sprinkler heads on or within two club lengths of the putting green when the ball lies off the putting green, is not in a hazard and within two club-lengths of the sprinkler head. Relief provided only for intervention for line of play between the ball and the hole. The player may take relief as follows: The ball shall be lifted and dropped at the nearest point to where the ball lay which is not nearer the hole, avoids the intervention and is not in a hazard or on a putting green. Ball may be cleaned when lifted. If the sprinkler head is located on the putting green and the ball also lies on the putting green on the line of putt the ball must be placed at the nearest point that avoids intervention.

Boundary: Indicated by barbed wire fence poles and white stakes.

Hole #4: Road beyond green: Ball in road is considered out of bounds; cement curbing is deemed to be an integral part of the course; ball that crosses the road and comes to rest on another part of the course is deemed to be out of bounds. Parking Lot is deemed to be out of bounds.

<u>Cart Path Extensions</u>: Worn areas leading into and bordering cart paths are considered extensions of that path and are deemed to be part of the same obstruction.

Caddie Rules: All Caddie Rules are waived.

<u>Replacing a Broken Club</u>: If a club is "broken or significantly damaged" during the round by the player or caddie, except in cases of abuse, the player my replace the club with any club under Rule 4.1.

Stone walls: Are deemed to be integral parts of the course.
