### **Stockholder Membership**

As our most prestigious category, the Stockholder Membership provides full access to the golf course, club amenities, programs and events for the primary member, their spouse/significant other and children through age 21. Available through the stockholder membership only; the fully redeemable stock provides voting rights and opportunity to be involved in club governance. The vertical family membership offers an additional membership to your parents and adult children. Our Troon Prive benefits offer global reciprocal private club access to the Troon network of clubs, and the inclusive fee structure provides our best value.

- Stockholder with Voting Rights. Invitation to Annual general meetings, committee and board participation. Club governance and legislative involvement.
- **Vertical Membership Privileges:** A Stockholder's family will have access to the facility for no additional dues or fees. Grandparents, Parents, Grandchildren, and Children can have their own member number and utilize the facility as a member, under the Stockholders Membership. Vertical members may book tee times up to 2 days in advance.
- First access to tee times. Reservations made up to 14 days in advance. The next highest membership level is 7 days advance.
- First right of refusal on all club golf tournaments, programs and activities.

- Vertical Membership Privileges: Subscription Member's Family will have access to the club for no additional dues or fees. Grandparents, Parents, Grandchildren, Children over the age of 21 all can have their own member number and utilize the facility as a member, under the Subscription Membership.
- Book tee time up to 7 days in advance
- Second right of refusal on all club golf tournaments.
- Access to all club social programs and activities
- Troon Prive' Privilege and Advantage Program –Pay only cart fees at dozens of Private Clubs around the United States and reduced rates at Troon Resort and Daily Fee Clubs

- Bag Storage & Range Fee: \$300 annually covers primary member & spouse
- Locker Fee: \$175 (Optional)

### **Intermediate Golf Membership**

*Primary age 36 through 40.*

Initiation Fee: \$1,500

2021 Dues: \$6,100 per year

Initiation Fee: \$1,000

### **Pure-Golf Membership**

The Pure Golf membership provides full access to the golf course, club amenities, programs and events for the primary member, their spouse/significant other and children through age 21.

- Book tee time up to 7 days in advance
- Troon Advantage access – Pay reduced rates at Troon Resort and Daily Fee Clubs around the world
- Third right of refusal to all Alpine Golf Tournaments
- Access to all club social programs and activities

#### **Initiation Fee:**

\$2,000

#### **2022 Yearly Dues:**

\$6,330 per year

#### **Bag Room, Range, Short Game Fee:**

\$300 includes primary member & spouse

#### **F&B Minimum:**

\$125 a month for primary member only



### **Corporate Golf Membership**

The Corporate Golf membership entitles four to six designated corporate employees to have full access to the golf course, club amenities, programs and events for the primary member.

### **No Corporate applications will be considered for Membership without the following information:**

- The past 2 paystubs of each corporate designee applying
  - A letter of good standing
  - An annual report
- Each designee will be provided individual benefits for the annual dues rate of \$3,740.
- The primary Corporate Designee must be an officer, partner, or sole proprietor of the entity enrolling in the club to be eligible for the Corporate Membership category
- Benefits apply to a minimum of four corporate designees. Corporate Membership, subject to Board of Director's approval may be expanded to include up to 6 designees.
- An additional upgrade fee of \$1,750 is required for each designee wishing to add family benefits, including spouse and children up to the age of 21
- The Primary Designee remains financially responsible for the total charges & fees applied to the total Corporate Account including each designee.
- Book tee time up to 5 days in advance
- Fourth right of refusal on all club golf tournaments (tournament restrictions apply)

### **Initiation Fee:**

\$1,000 per designee

### **2022 Yearly Dues:**

\$3,740 per individual designee

\$5,490 for a family

### **Bag Room, Range, Short Game Fee:**

\$300 per designee

### **F&B Minimum:**

### **Non-Resident Golf Membership**

The Non-Resident Golf membership is a golfing membership with access to the Club from May–October. The membership is a full golfing membership with privileges extending to their spouse/significant other and children through age 21.

- Book tee time up to 7 days in advance
- Troon Advantage access –Pay reduced rates at Troon Resort and Daily Fee Clubs around the world during the months of May-October.
- Third right of refusal on all club golf tournaments (tournament restrictions apply)
- Access to all club social programs and activities from May-October

#### **Initiation Fee:**

\$1,000

#### **2022 Yearly Dues:**

\$5,205 per year

#### **Bag Room, Range, Short Game Fee:**

\$300 includes primary member & spouse

#### **F&B Minimum:**

\$125 a month for primary member only May-October





### **Social Golf Membership**

As a great way to get introduced to the benefits of club life, the Social Golf membership includes limited golf, full access to the pool & member dining, club social events and programs. This membership category extends privileges to the spouse/significant other and children up to age 21.

- Each family member may play up to 2 (18 hole rounds) or 4 (9 hole rounds) per month. The two rounds per family member may not be distributed amongst each other.
- Book tee time up to 4 days in advance
- Access to member dining, pool and club social programs and events

#### **Initiation Fee:**

\$500

#### **2022 Yearly Dues:**

\$3,600

#### **Bag Room, Range, Short Game Fee:**

\$300 includes primary member & spouse

#### **F&B Minimum:**

\$125 a month



### **Social Membership**

This membership category is a great introduction into the country club lifestyle. Benefits include full access to the pool & dining, and limited access to golf. These privileges extend to spouse/significant other and children through age of 21.

- Access to member dining, pool and club social programs and events
- Each family member may play up to 2 rounds annually
- Book tee time up to 2 days in advance

#### **Initiation Fee:**

\$500

#### **2022 Yearly Dues:**

\$2,250

#### **F&B Minimum:**

\$125 a month



### **Vertical Members:**

*(Stockholders & Subscription Golf Memberships Only)*

The Vertical privilege is extended to all Stockholders and Subscription Golf members at the Alpine Country Club. The parents, children and grandchildren of Stockholders and Subscription Golf members are eligible to enjoy the Clubhouse Amenities & Golf Course under these strict rules & regulations.

Family members (grandparents, parents & children/grandchildren) of Stockholders or Subscription Golf members may use the club unaccompanied over the age of 16 on the golf course, use of the pool, and use of the dining outlets and club social events.

### **CLUBHOUSE PRIVILEGES:**

- Clubhouse, Dining, and pool access

### **GOLF PRIVILEGES:**

- Yearly, the first 20 rounds for a Vertical Member Cost: \$25 cart fee
- Any round over 20 will cost \$50 for Vertical Members
- Vertical Members under the age of 18 must pass a golf course etiquette course with the Club's Golf Professional
- Access to golf course: 2 day advanced booking
- Driving range access with \$300 yearly fee
- Vertical members under the age of 21 are eligible to play in the 3 Member/Member tournaments which include the Spring Member/Member, the Tradition, and the Fall Member/Member.
- Vertical designees over the age of 21 are ***NOT*** eligible to participate as a member in any club sponsored golf tournaments but may participate in the member/guest.
- Troon Advantage access

### **Rules & Regulations:**

- Vertical members shall be issued a permanent individual membership number.
- Vertical members shall be responsible for their own Club charges and purchases will not be applied to any club minimums.
- Any delinquent charges from Vertical designees are ultimately the responsibility of the Stockholder or Subscription Golf member.
- Vertical members will have no right to vote.
- Vertical members are subject to all rules and regulations in place at the Club.
- Vertical members may bring guests for guest fees during the proper club tee times.
- Vertical members may bring guests to the pool for applicable guest fees.
- Eligibility for designation is at the complete discretion of the Stockholder. Upon request by Stockholder, the privileges of a vertical member may be revoked at any time.
- All golfing verticals are subject to a \$300 Bag Storage/Range & Short Game Fee
- Vertical members are subject to the \$175 locker fee if lockers are available and they wish to participate.
- The Club reserves the right to edit these privileges at any time, for any reason.
